# **Chapter 1. General Provisions**

# Article 1.

- 1. The purpose of Rikkyo University (the University) is to cultivate human character based on the spirit of Christianity, while teaching and researching the theoretical and practical domains of academic inquiry in accordance with the School Education Act, pursuing the depths of intellectual activity.
- 2. The purpose of each college relating to the development of human resources, along with other teaching and/or research-related objectives, shall be listed in Attachment 7.

# Article 2.

1. The University shall have undergraduate colleges and graduate schools.

# Article 3.

 The University's undergraduate colleges and departments, and their respective student capacities, shall be as follows

#### Article 4.

- 1. The minimum period of enrollment for students of the same college, department and program since the 1st year of study shall be four (4) years; however, the maximum period of enrollment shall be eight (8) years.
- 2. The minimum period of enrollment for students of a certain college/department by transfer admission or by internal transfer (changing college and/or department) in the 2nd year of study shall be three (3) years; provided, however, that the maximum period of enrollment shall be seven (7) years.
- 3. The minimum period of enrollment for students of a certain college/department/course by transfer admission or by internal transfer (changing college, department and/or course) in the 3rd year of study shall be two (2) years; provided, however, that the maximum period of enrollment shall be six (6) years.
- 4. Notwithstanding the provisions of Paragraph 1, the term of study for students enrolled in the NEXUS Program (excluding those enrolled in the College of Intercultural Communication) shall be 4.5 years (9 semesters). However, the maximum period of enrollment shall be eight (8) years.

#### Article 5.

- 1. The University shall confer bachelor's degrees upon students who have been enrolled in the same department for four (4) years or more since the 1st year of study, pass the stipulated examinations, and have acquired the stipulated credits. However, for those enrolled in the NEXUS Program (excluding those enrolled in the College of Intercultural Communication), the period of enrollment shall be at least 4.5 years (9 semesters)
- 2. The University shall confer a bachelor degree upon students who have been enrolled in the same department of the college for three (3) years or more since the 2nd year of study, having enrolled in the relevant college/department by transfer admission or internal transfer (changing college and/or department), passed the stipulated examinations and acquired the stipulated credits.
- 3. The University shall confer bachelor degrees upon students who have been enrolled in the same department of the college, for two (2) years or more (commencing from the 3rd year of study), having enrolled in the relevant college/department/course by transfer admission or internal transfer (changing college, department and/or course), passed the stipulated examinations and acquired the stipulated credits.
- 4. The degree to be conferred by the department or course of each college shall be as follows.

# Article 5-2

- 1. Notwithstanding the provisions of the preceding two articles, the College of Law and Politics shall confer a bachelor's degree on students who have attended the Legal Course of department of law of the College of Law and Politics for three (3) years or more, passed the prescribed examinations, and have acquired the prescribed credits with excellent grades.
- 2. Students who have been permitted to study in the Legal Course of the Department of Law, College of Law and Politics must pay the registration fee indicated in Attachment 8 within the designated period.

# Article 6.

1. The University's academic year shall begin on April 1 and end on March 31 or on September 20 and end on September 19 of the following calendar year.

# Article 7.

1. The University's academic year shall be divided into the following 2 semesters.

Spring Semester: April 1 through September 19
Fall Semester: September 20 through March 31

# Article 8.

- 1. The University shall observe the following holidays and have recesses.
  - (1) Sundays
  - (2) National holidays as stipulated in the Act on National Holidays
  - (3) Rikkyo University Foundation Day (May 5)
  - (4) Spring recess (from early February until late March)
  - (5) Summer recess (from late July until mid-September)
  - (6) Winter recess (from late December until early January)
- 2. The University may change the holidays and recesses stipulated in the preceding paragraph, and may fix special holidays.

### **Chapter 2. Educational Curriculums**

#### Article 9.

- A class subject for one credit shall normally be organized to contain contents that require 45 hours of learning.
   The number of credits shall be calculated based on the following standards, in light of the educational effects of said class and required learning other than that during class hours, in accordance with class methods:
  - (1) regarding lectures and seminars, one credit shall consist of classes conducted for between 15 hours and 30 hours.
  - (2) regarding group reading, experiments, practical training and skills practice, one credit shall consist of classes conducted for between 30 hours and 45 hours.
- 2. Notwithstanding the provisions of the preceding paragraph, regarding class subjects, such as a graduation thesis and graduation research, etc., when it is deemed to be appropriate to grant credits by evaluating the achievements of such learning, the number of credits may be determined in light of the learning, etc. necessary for these activities
- 3. The University may allow students to take classes in the form of lectures, seminars, lecturing in turn, experiments, and Practical training and practical skill classes prescribed in paragraph 1 at places other than the classrooms where said classes are held by making advanced use of a variety of media, as specified separately by the Minister of Education, Culture, Sports, Science and Technology when University deems it effective from an educational standpoint.

#### Article 10.

- Students must take the courses and obtain credits as stipulated in Articles 13 to 18-7 of the University Regulations (the Regulation).
- In the case of university-wide liberal arts courses and specialized courses, with the exclusion of designated
  courses that can only be taken from a specified year of study, the University shall require students to take these
  courses in either year of study.

### Article 10-2.

- The University may, when deeming it to be effective from an educational standpoint, regard credits that its
  student has acquired by completing class subjects at other universities or junior colleges, as credits acquired by
  completing class subjects at the University, to an extent not exceeding 60 credits, in accordance with the
  regulations stipulated by the relevant College Faculty Meeting.
- 2. The provisions of the preceding paragraph shall apply mutatis mutandis to cases where a student studies at a foreign university or junior college.

### Article 10-3.

- 1. The University may, when deeming it to be effective from an educational standpoint, deem its student's learning at junior college or at an advanced course at a technical college or other learning specified separately by the Minister of Education, Culture, Sports, Science and Technology to be his/her learning of class subjects at the University, in accordance with the regulations stipulated by the relevant College Faculty Meeting.
- 2. The number of credits that the University can grant in accordance with the preceding paragraph shall not exceed 60 credits, together with the number of credits deemed to have been acquired at said university under paragraphs 1 and paragraph 2 of the preceding article.

#### Article 10-4.

1. The University may, when deeming it to be effective from an educational standpoint, deem credits that its student has acquired by completing class subjects at other universities or junior colleges prior to being admitted to the

- University (including credits acquired as a credited auditor) to be credits that he/she has acquired by completing class subjects at the University after being admitted, in accordance with the regulations stipulated by the relevant College Faculty Meeting.
- 2. The University may, when deeming it to be effective from an educational standpoint, deem its student's learning prior to being admitted to the University as prescribed in paragraph 1 of the preceding article to be his/her learning of class subjects at the University and grant credits, in accordance with the regulations stipulated by the relevant College Faculty Meeting.
- 3. The number of credits other than those acquired or which can be granted as prescribed in the preceding two paragraphs, shall not exceed 60 credits, together with the number of credits deemed to have been acquired at the University under paragraphs 1 and paragraph 2 of Article 10-2 and paragraph 1 of the preceding article, except for cases of mid-course entry and transfers, etc.

# Article 10-5

1. The number of credits that can be acquired by completing the class subjects stipulated in Article 9, paragraph 3 shall be up to 60 credits for graduation requirement in the prescribed credits stipulated in Articles 13 to 18-7.

#### Article 11.

- Students wishing to obtain a Type I school teacher's license for elementary school, junior high school or high school must take the specialized class subjects relating to teaching subjects as timetabled under each college, department and course, and the specialized class subjects relating to the teaching profession timetabled under the College of Arts' Department of Education that are required in order to obtain a school teacher's license for elementary, junior high school or high school; and must acquire the credits for these subjects.
- 2. The types of teacher's licenses and subject types for which licenses can be obtained from each of the University's colleges, departments, courses and programs are as follows.

- Students admitted from the 2000-01 academic year onwards may obtain teacher's licenses in the Information Technology and Social Work subjects.

#### Article 12.

- 1. In addition to the stipulated credits for their college and department, students wishing to obtain a curator qualification must also take subject and acqire credits for such subjects relating to museums and curatorship as stipulated in Article 19 of the Regulations. Such subjects and credits relating to museums and curatorship shall not be regarded as the class subjects and credits stipulated in Article 10 of the Regulations.
- 2. Students wishing to obtain a librarian or school librarian qualification must take and acquire credits for the subjects relating to libraries and librarianship as stipulated in Article 19 of the Regulations. Such subjects and credits relating to libraries and librarianship shall not be regarded as the class subjects and credits stipulated in Article 10 of the Regulations.
- 3. Students wishing to obtain a Social Education Secretary qualification must take and acquire credits for the subjects relating to Social Education as stipulated in Article 19 of the Regulations. Such subjects and credits relating to Social Studies education shall not be regarded as the class subjects and credits stipulated in Article 10 of these Regulations.

# **Chapter 3. Examinations**

# Article 20. -- deleted

# Article 21.

- 1. Examinations shall be conducted to determine pass or failure for each class subject.
- 2. Examination shall be scored on a 100-point scale, and a score of 60 points or higher shall be recognized as a passing examination otherwise recognized as a failure.
- The specified number of credits for the relevant class subject will be awarded to students who have passed the examination for that subject.

#### Article 22.

Students who are unable to sit examinations due to be reavement leave or other such reasons may sit makeup examinations

#### Article 23.

Students shall not sit examinations during a leave of absence.

# Chapter 4. Admissions, Mid-Course Entry, Leaves of Absence, Re-enrollments, Withdrawals, Readmissions and Dismissals

(Admissions)

# Article 24.

- 1. Persons who are permitted admission to the University as first-year students shall be qualified as any one of the following subparagraphs, passed an entrance examination, and completed the specified admission procedures.
  - (1) Persons who have graduated from high school (secondary school).
  - (2) Persons who have completed an ordinary 12-year curriculum of school education.
  - (3) Persons who have completed a school education other than an ordinary 12-year curriculum, but equivalent to that stipulated by the preceding subparagraph.
  - (4) Persons who have completed a school education curriculum of 12 years or more overseas, or persons designated by the Minister of Education, Culture, Sports, Science and Technology as being equivalent to having done so.
  - (5) Persons who have completed a curriculum at an overseas educational institution that has been certified by the Minister of Education, Culture, Sports, Science and Technology as having a curriculum equivalent to that of a Japanese high school.
  - (6) Persons designated by the Minister of Education, Culture, Sports, Science and Technology (Ministry of Education, Science and Culture Order No. 47 of 1948).
  - (7) Persons who have passed the examination for the Certificate for Students Achieving the Proficiency Level of Upper Secondary School Graduates in accordance with the Certificate for Students Achieving the Proficiency Level of Upper Secondary School Graduates Regulations (Ministry of Education, Culture, Sports, Science and Technology(MEXT) Order No. 1 of 2005); including persons who have passed the old University Entrance Qualification Examination in accordance with the University Entrance Qualification Examination, Science and Culture Order No. 13 of 1951) prior to its abolishment, in accordance with Article 2 of the Supplemental Provisions of those Regulations (MEXT Order No. 1 of 2005).
  - (8) Persons other than those stipulated in the preceding subparagraphs, persons who have reached the appropriate age and are recognized by the University as having academic ability equivalent to or above that of a high school graduate.

# Article 24-2.

Notwithstanding the provisions of preceding Article of these Regulations, graduates of Rikkyo Niiza Senior High School, Rikkyo Ikebukuro Senior High School, Nippon Sei Ko Kai (NSKK)-affiliated high schools or other designated high schools under the University's recommendation-based admission system who have been recommended to the University by the principal of their school may be exempted from part or all of the entrance examinations.

(Mid-Course Entry)

# Article 25.

Persons who are permitted admission to the University by mid-course entry or permitted to make internal transfers (change of college, department and/or course) as second-year (or higher year) students must be eligible for mid-course entry or internal transfer as stipulated separately by the University; and must have passed a selective examination and completed the admission procedures stipulated by the University.

#### Article 26.

- 1. Foreign nationals who are not eligible for admission under Article 24 of the Regulations, but who have a recommendation by a foreign diplomatic mission may be permitted to study subject to eligibility screening.
- 2. The Regulations shall apply mutatis mutandis to persons who are permitted to study in accordance with the preceding paragraph, with the exclusion of Article 5.

# (Admission Period)

#### Article 27.

- 1. The admission period shall be the beginning of the relevant academic year or semester.
- 2. The admission period for special international students as stipulated in Article 50-2 shall be April 1 or September 1 of each year.
- 3. The admission period for short-term program students as stipulated in Article 51-3 shall be according to the bylaws specified separately.

# (Admissions Application Procedure)

#### Article 28.

Persons wishing to apply for admission to the university must submit an application form, an academic transcript from their previous school (certified by the school principal) and a photograph of themselves, and must pay the necessary application fee, as indicated in the Attachment 2-1 or 2-2.

# (Enrollment Procedures)

### Article 29.

- Persons who have passed the entrance examination and wish to be enrolled at the University must determine a
  personal guarantor; and must submit a guarantor notification form and complete other admission procedures
  stipulated by the University by the designated date.
- Only persons who have completed the procedures described in the preceding paragraph shall be permitted enrollment.

# Article 30.

The guarantor shall be responsible for any and all matters relating to the relevant student for the duration of their enrollment at the University, and such guarantor must be the student's mother or father or person who acts in place thereof.

# Article 31.

In the event of the death of a student's guarantor or other failure to meet the requirements of the preceding article, the student must determine a new guarantor, and submit a new guarantor notification form to the University without delay.

### (Leaves of Absence and Re-enrollments)

# Article 32.

1. When a student is unable to attend university for a period of two (2) full months or more due to illness or some

other compelling reason, the student may be permitted a leave of absence for the semester by submitting a written request, cosigned by his/her guarantor. In addition, university may ask the submission of a document to prove the fact

- 2. Periods of leaves of absence are not included in a student's periods of enrollment.
- 3. Students shall not take more than eight (8) separate leaves of absence during their time at the University.
- 4. Students who have taken a leave of absence may re-enroll at the University at the beginning of a new semester, at the end of a period of absence, as stipulated in Paragraph 1 of this article.

#### (Withdrawals)

# Article 33.

Students wishing to withdraw from the University due to illness or some other reason must receive permission to do so by submitting a written request, cosigned by their guarantor.

# (Readmissions)

#### Article 34.

When persons who have withdrawn from the University by their request wish to request readmission, the University may permit them to do so at the beginning of the academic year or semester. Such persons shall be readmitted to the same grade as he/she had withdrawn.

#### Article 35.

Students who have been permitted readmission to the University must complete the procedures stipulated in Article 29 of the Regulations.

# (Dismissals)

# Article 36.

- 1. Students who fall under the following items shall be dismissed from the University.
  - (1) Students who exceed the maximum periods of enrollment stipulated in the each paragraph of Article 4 of the Regulations.
  - (2) Students who do not pay their academic fees.

# Article 36-2

 Admissions, transferring to the university, leaves of absence, withdrawals and readmission permits and dismissals are to be done by the President after the College Faculty Meeting.

# Chapter 5. Studying Abroad

# Article 37.

- Subject to passing the screening system and upon the request of a student wishing to study abroad in order to take class subjects at the Foreign Universities (a foreign university or equivalent higher educational institution) which have already concluded an agreement for mutual exchange of students or has agreed with the University in terms of studying abroad, or a university or equivalent higher educational institution which the University deems as comparable to the Foreign Universities, the University may, when deeming it to be effective for students from an educational standpoint, permit such students to study abroad.
- 2. The study abroad permitted in accordance with the preceding paragraph is classified into either "Zaigaku Ryugaku (study abroad without leave of absence)" or "Kyugaku Ryugaku (study abroad with leave of absence)".

# Article 38.

1. For students who have been permitted to study abroad as Zaigaku Ryugaku, the permitted period may be included in the student's period of enrollment.

#### Article 39.

- 1. Credits and other results acquired at foreign universities, etc. by students who have been permitted to study abroad as Zaigaku Ryugaku, may be recognized as credits required for graduation from the University in accordance with paragraph 2 of Article 10-2 of the Regulations, if the College Faculty Meeting deems it appropriate to do so.
- 2. Among the credits or achievements that a student who has been granted permission to take a leave of absence to study abroad has acquired at the university where he or she studied, those that are deemed appropriate by the College Faculty Meeting may be approved as credits of Rikkyo university in accordance with paragraph 2 of Article 10-2.

# Article 40.

The Article 32 of the Regulations shall apply mutatis mutandis to leaves of absence taken for the purpose of study abroad on a leave of absence.

# Chapter 6. Academic Fees and Other Payments

#### Article 41.

- Persons having passed an entrance examination and wishing to be admitted to the University must pay academic
  fees as indicated in the Attachment 2-3 and 2-4, or in the Attachment 2-3 and 2-5 during the designated
  enrollment procedure period.
- 2. Students must pay academic fees as indicated in the Attachment 2-4 by the designated date after the commencement of classes each academic year.
- Of the academic fees stipulated in paragraphs 1 and preceding paragraph of this article, payments of tuition fees
  and experiment and practical training fees shall be divided into installments between the Spring Semester and
  the Fall Semester.

# Article 42.

1. The term "academic fees" shall refer to admission fees, tuition fees (including semester enrollment fees) and experiment and practical training fees.

# Article 43.

 Academic fees must be paid during leaves of absence. The amount of academic fees payable in this case shall be stipulated separately.

# Article 44.

 Academic fees must be paid even in the event of withdrawal midway through an academic year. The amount of academic fees payable in this case shall be stipulated separately.

#### Article 45.

1. Excluding the cases provided for under Paragraphs 2 and 3 of this article, academic fees and other payments that have already been paid shall not be returned.

- 2. Academic fees and other payments (with the exclusion of admission fees) shall be returned to persons who have passed an entrance examination and paid academic fees and other payments required for admission to the University, but who have subsequently submitted a Rejection of Admission Offer form in accordance with the procedures stipulated by the University, citing unavoidable reasons.
- 3. Academic fees and other payments (including admission fees) shall be returned, upon request, to persons who were expected to graduate (from high school, etc.,) or expected to obtain the prescribed number of credits, etc., at the time of application, who have passed an entrance examination and paid academic fees and other payments required for admission to the University, but who have subsequently been determined to be unable to graduate and/or obtain the prescribed number of credits and have therefore become unable to fulfill the eligibility requirements for admission to the University.

#### Article 46.

1. In the event that academic fees and/or other fees are subject to change during their enrollment at the University, students must pay such fees in accordance with the newly stipulated tariff.

# Article 47.

 Students taking specialized subjects relating to the teaching profession that are required to obtain a school teacher's license, a qualification for curator, a qualification for librarian or school librarian, and/or qualification for social education secretary must pay separate tuition fees as indicated in Attachment 3.

#### Article 48. -- deleted

#### Article 49.

Students who request a certificate, etc., must pay the handling fees indicated in Attachment 5.

#### Article 50.

For students who fail to pay their academic fees on time, the University shall not award credits for the current year of study, shall not approve research guidance, and shall not confer degrees.

# Chapter 6-2. Special International Students

# (Special International Students)

#### Article 50-2.

The University may permit the admission of students who dispatched by foreign universities that have agreements with the University, and foreign students delegated to the University by the governments and other institutions or organizations, as special international students on the basis of a review by the College Faculty Meeting etc..

# Article 50-3.

Special international students who have been permitted admission to the University must complete the admission procedures stipulated by the University and pay the necessary fees, which shall be stipulated separately.

#### (Awarding of Credits)

# Article 50-4.

The University may award the specified numbers of credits with regard to class subjects taken by special international students.

# (Mutatis Mutandis Application)

# Article 50-5.

The Regulations shall apply mutatis mutandis to special international students except for Article 5.

# Article 50-6.

In addition to prescribing in the preceding Article 4, necessary matters concerning acceptance of special International students are specified in the by-law on acceptance of special international students prescribed in the Rikkyo University regulations and Rikkyo University Graduate School Regulations.

### Chapter 7. Credited Auditors, Special Auditing Students and Short-term Program Students

# (Credited Auditors)

#### Article 51.

- 1. The University may, upon selection, permit persons who request to take one or more class subjects, from amongst the specified class subjects offered by the University's colleges and/ or prescribed university-wide liberal arts subjects, to study at the University as credited auditors.
- The University may, upon selection, permit persons who request to take specified class subjects offered by the
  Teacher Training Course, the Curator Course, the Librarian Course and the Social Education Secretary
  Supervisor Course, to study at the University as credited auditors.
- 3. Persons requesting to study at the University as credited auditors must pay the application fees indicated in Attachment 6.
- 4. Where credited auditors have passed class subjects that they have taken, the University shall award them the specified numbers of credits for those subjects.

# (Special Auditing Students)

# Article 51-2.

- The University may permit students of other universities and other educational institutions that have agreements
  with the University who request to take one or more class subjects at the University to participate in study at the
  University as special auditing students.
- 2. When special auditing students have passed class subjects that they have attended, the University shall award them the specified numbers of credits for those subjects.

# Article 51-3.

- Students who are enrolled in higher education institutions mainly in overseas universities and other institutions
  who wish to participate in short-term educational programs conducted by each college or other organizations
  shall sometimes be permitted as short-term program students.
- 2. In case of the short-term students pass the class, each college or other organizations can award students the prescribed credit.

# (Registration Fees and Tuition Fees)

# Article 52.

Persons permitted to study at the University as credited auditors under the provisions of Paragraphs 1 and 2 of Article 51 of the Regulations must pay registration fees and tuition fees as indicated in Attachment 6 within the designated period.

#### Article 53. -- deleted

(Mutatis Mutandis Application)

#### Article 54.

- With the exclusion of Article 5, these Regulations shall apply mutatis mutandis to credited auditors and special student auditors. Detailed regulations other than stipulated in Articles 51, 51-2 and 52 shall be stipulated separately.
- 2. For the short-term program students, except for Article 5 and Article 36-2 shall apply mutatis mutandis of University regulations, and matters other than those prescribed in Article 51-3 shall be prescribed separately.

### **Chapter 8. Awards and Penalties**

#### Article 55.

1. The University shall award prizes to students who contribute to improving the good name of the University by displaying exceptionally good conduct and academic performance, or performing particularly good deeds.

#### Article 56.

- 1. The University shall discipline students who violate the Regulations or perpetrate acts that go against the University's educational policy.
- 2. The University may use three types of disciplinary measures: reprimands, suspensions and dismissals (i.e. forced withdrawal).
- 3. The University shall dismiss students if one of the following items applies.
  - (1) Persons with poor academic performance who are found to show no hope of achievement
  - (2) Persons who are generally badly behaved and are found to show no hope of improvement
  - (3) Persons who disrupt the order of the University or otherwise act significantly against their duties as students
- 4. The following items may be applied to students who have been suspended by the University, depending on the specific nature of their actions.
  - (1) The University may choose not to include the period of suspension in the calculation of the student's period of enrollment.
  - (2) The University may choose not to permit the student's graduation in the current academic year.
- 5. The following items shall apply during periods of suspension.
  - (1) As a general rule, during suspension, except when there have been specific instructions from the University to do so, students shall not come to the University.
  - (2) Where the period of suspension spans half or more of the total number of class hours for a particular class subject, the student shall not be permitted to obtain credits for the subject.
  - (3) During suspension, students shall not request to take a leave of absence.
  - (4) During suspension, students shall not study abroad as provided for under Article 37 of these Regulations.

# Article 57.

1. Awards and penalties shall be given by the President, after discussion by the College Faculty Meeting.

# (Dean of Graduate School)

#### Article 60-2.

1. The Dean of each graduate school shall take primary responsibility for the management of that graduate school.

1. The Chair of each graduate program shall assist the Dean of their graduate school in relation to his or her duties.

#### Article 62.

1. The Dean of the Center for the University-wide Curriculum shall take primary responsibility for the management of university-wide (liberal arts) curriculum subjects.

# (Dean of Center for Foreign Language Education and Research)

# Article 62-2.

 The Dean of Center for Foreign Language Education and Research shall take primary responsibility for the management of matters relating to Center for Foreign Language Education and Research.

# (Dean of Certification Courses)

### Article 62-3.

 The Dean of Certification Courses shall take primary responsibility for the operation and management of certification courses at the University.

# (Chair of Certification Course)

# Article 62-4.

The Chair of each certification course shall take primary responsibility for the operation and management of his
or her respective course.

1. The Dean of the University Library shall take primary responsibility for the management of matters relating to the University Library.

1. The Director of the Center for the Global Liberal Arts Program (GLAP) shall take primary responsibility for the management of matters relating to the Center for the Global Liberal Arts Program (GLAP).

(Director of the Students with Disabilities Support Office)

#### Article 68-24.

 The Director of the Students with Disabilities Support Office shall take primary responsibility for the management of matters relating to the Students with Disabilities Support Office.

(Chair of Undergraduate Department)

# Article 69.

- The Chair of each undergraduate department shall assist the Dean of their college in relation to matters
  concerning his or her respective department (in the Department of Arts, this excludes GLAP).
- Team Leaders at the Center for the University-wide Curriculum's Development & Management Team shall
  assist the Dean and Deputy Assistant Dean of the Center for the University-wide Curriculum in relation to
  matters concerning their respective Development & Management Team.

(Manager etc.)

#### Article 70.

Chief Managers, Managers, Associate Managers, Assistant Managers and Advisers shall assist their superiors
and take responsibility for matters relating to their respective areas of responsibility.

(Professor)

### Article 71.

1. Professors shall teach and provide research guidance to students, and/or engage in research themselves.

(Associate Professor)

### Article 72.

1. Associate Professors shall teach and provide research guidance to students, and/or engage in research themselves.

(Senior Specially Appointed Professor)

### Article 72-2.

1. Senior Specially Appointed Professors shall teach and provide research guidance to students, and/or engage in research themselves.

(Assistant Professor)

#### Article 72-3.

1. Assistant Professors shall teach and provide research guidance to students, and/or engage in research themselves.

(Lecturer)

#### Article 72-4.

1. Lecturers shall engage in duties similar or equivalent to those of Professors and Associate Professors.

(Counselor)

1. Counselors shall provide counselling services and support for the personal growth and development of students.

# Article 74-2.

Adjunct Lecturers engage in educational (teaching) duties under the direction of the head of the Center to which

# Article 74-3.

 Specially Appointed Faculty Members engage in educational (teaching) duties and research mainly at the University's undergraduate colleges and/or graduate schools under the direction of the Deans of the relevant colleges and/or schools etc.

 Lecturers in English Education engage in educational (teaching) duties under the direction of the head of the Center for Foreign Language Education and Research, etc.

# Article 75.

 Laboratory Technicians provide support in technical aspects of research and teaching at the University, under the direction of Professors, Associate Professors, Lecturers, Senior Specially Appointed Professors and Assistant Professors

(Administrative Staff etc.)

# Article 76.

 Administrative Staff, Librarians, Technicians, Medical Technicians, School Affairs Staff, Contractors and Program Officers engage in various duties in their respective areas of responsibility, in accordance with the division of labor for their respective positions.

#### **Chapter 10. Faculty Meetings**

#### Article 77.

- 1. Each college at the University shall establish a Faculty Meeting.
- Each college's Faculty Meeting shall be composed of Professors and Associate Professors from that college.
   However, full-time Lecturers may also join a college's Faculty Meeting when it is determined acceptable by the relevant college for them to do so.
- 3. Each college's Faculty Meeting shall deliberate over matters relating to college personnel issues, the election of the college's Dean, educational curriculums, examinations, student admissions, transfer admissions, graduations, leaves of absence, withdrawals, readmissions, dismissals, internal (college and department) transfers, awards, penalties and other matters relating to the college, as well as matters concerning advising the President.
- 4. Detailed regulations relating to Faculty Meetings shall be stipulated separately.

# Article 77-2. -- deleted

#### Article 77-3.

- In the case of GLAP, the Center for the Global Liberal Arts Program Committee (hereinafter referred to as the GLAP Center Committee) shall be deemed to constitute a Faculty Council as provided for under Paragraph 1 of Article 77 of these Regulations; and the provisions of Articles 10-2 through 10-4, Article 36-2, Article 39, Article 57 and Article 77 (Paragraph 3; excluding the provision regarding the election of the college's Dean) shall apply with regard to it.

- In addition to the provisions of the preceding paragraph, other necessary matters relating to the GLAP Center Committee and the management and operation of GLAP shall be stipulated separately.

# Article 77-4

- 1. For special international students who belong to the Center for Japanese Language Education, apply Article 50-2 by regarding the Steering Meeting of the Center for Japanese Language Education (hereinafter referred to as the "Steering Meeting") as a College Faculty Meeting prescribed in Article 77, paragraph 1. In this case, the term "College Faculty Meeting" in the regulations is "Steering Meeting of the Center for Japanese Language Education".
- In addition to the preceding paragraph, necessary matters regarding the management of the Steering Meeting
  of the Center for Japanese Language Education and other courses of the Center for Japanese Language
  Education shall be separately determined.

# Chapter 11. Attached Facilities

# Section 1. Chapels

#### Article 78.

1. The chapels shall symbolize the founding spirit of the University, and the purpose of it is to enable faculty members, staff and students to live Christian lifestyles based on the beliefs, rules and precepts of the Anglican-

Episcopal Church of Japan (the Nippon Sei Ko Kai).

#### Article 79.

- 1. The chapels shall carry out the following events.
  - 1. Service
  - 2. Various University ceremonies
  - 3. Lectures relating to Christianity
  - 4. Biblical research
  - 5. Other Christian events

# Section 2. Library

# Article 80.

 The University Library shall be comprised of the Ikebukuro Library, the Niiza Library, and the Niiza Repository Library.

#### Article 81.

1. The materials stored in the University Library shall be made available to faculty members, staff and students of the University, and other persons expressly specified by the University Library.

# Article 82.

 Books and other materials on open shelves in the viewing rooms may be viewed freely. Other materials may be viewed or used by completing the procedures stipulated by the University.

# Article 83.

1. Detailed regulations relating to the borrowing of materials stored at the various libraries shall be stipulated separately.

# Article 84.

 Detailed regulations relating to the opening days and opening times of the various libraries shall be stipulated separately.

# Section 3. Clinic

# Article 85.

 The purpose of the Clinic is to improve attitudes towards health and hygiene, preventing illness and conducting medical examinations for faculty members, staff and students.

### Article 86.

- 1. In order to achieve its objectives, the Clinic shall conduct the following activities.
  - (1) Regular (scheduled) and irregular health checks
  - (2) Administration of medical treatment
  - (3) Holding of lectures relating to health and hygiene
  - (4) Other activities as deemed necessary

# Article 87.

1. Detailed regulations relating to the Clinic, including its organizational structure and other matters, shall be

stipulated separately.

# **Section 4. Student Counseling Center**

#### Article 88.

 The purpose of the Student Counseling Center is to carry out counseling with regard to problems being faced by students

### Article 89.

1. Detailed regulations relating to the Student Counseling Center, including its organizational structure and other matters, shall be stipulated separately.

# Section 11. Research Institutes

#### Article 90.

1. The University shall establish research institutes, research centers and other attached educational and research institutions (hereinafter referred to, collectively, as "research institutes, etc.").

#### Article 91.

 Other regulations regarding the research institutes, etc., provided for under the preceding paragraph shall be stipulated separately.

# Chapter 12. Amendments and Repeal

# Article 92.

- Amendments and repeal of these regulations shall be made by the President, in turn, after consultation with the University Deans' Council and the Executive Board.
- Notification or application to the competent authorities in relation to the preceding paragraph shall be as prescribed by the competent authorities.
